As this is the year for the new Property Assessments we have included an article about the method to challenge your assessment if you are not in agreement.

# **Councillor's Messages:**

Winter has finally ended and the warm weather has finally arrived. This was a very strange winter. There was not a lot of snow up until the end of March and beginning of April. Cold weather hung on for some time.

Anyway welcome back to the Lake. South Algonquin has finally had its 911 service installed. However please ensure it is only used for emergencies. Also be aware of pocket dials. With the new policing pricing model false calls are paid for by tax payers of South Algonquin. This is a significant portion of our policing costs. Also please as much as possible use the OPP self reporting website at www.opp.ca/reporting. This is for police calls that are not emergencies as this reduces the calls for service and will reduce our overall police costs which affect your taxes. This is for things like small thefts etc. If an officer is dispatched the cost is quite high and counts towards our calls for service. In 2015 our policing costs were just over \$ 278,000 for the year, this year's budget has been increased to over \$ 332,000, a \$ 54,000 or 19 % increase. So whatever we can do as a municipality to reduce the calls for service is in our best interests.

The Algonquin land Claim proceeded with its vote in March. The result is open to various interpretations. There were apparently 7540 eligible voters of which 3,575 or 47 % actually voted. Of the 3,575 voters, 3,341 of those supported it, which is about 92 %. The Algonquins of Pikwakanagan voted over 243 against and only about 80 for. The following is a quote from Robert Potts the chief negotiator:

"This is one of the most complicated of land claims processes, probably in Canada," he said in a telephone interview with The Daily Observer, "and it has a multitude of issues that have to be dealt with from the fact that you're dealing with a million-plus people living within the region of the territory; you have 80-plus municipalities, one of which just happens to be the nation's capital, all sitting on unceded Algonquin land; you've got a vast number of interest groups whether they be cottage associations, industries like gravel pit operators, you've got forest licensees, you've got hunt camp operators, all of these interest groups entangled in this; and then you've got a group of people who have been waiting roughly 250 years to have this thing to be brought to a conclusion, and all of them have to come to an agreement and solve a whole vast array of problems."

Asserting that the whole point of the AIP was to "take the temperature" of the people he represents at the negotiating table, Potts says that getting feedback on areas of the agreement that need more work was exactly the point of the exercise, and it was never intended to be a final document of any kind.

"It's a step in a very lengthy process," he says. "We're going to get it right, and we're going to get it done. That's the simple answer. But we're not going to run roughshod over anybody and we really do respect everybody's right to take the time they need to sort situations out."

So other than the results of the vote we have not had any further information provided to us.

As part of this year's budget there is going to be improvements made at the landing facility at Aylen Lake. By the time you receive this newsletter the new larger dock should be in place. The Municipality is supplementing the existing docking facility with additional dock and launching facility.

Further to the 911 implementation I still have a large number of Civic Address signs at my place for water access properties. When Civic addressing was first introduced before I came on council over 5 years ago it was mentioned that the water access cottages all wanted to have civic addressing similar to the road access properties. However I have had these signs for over 3 years and it has been mentioned in every newsletter and at the Township office that these signs are available at the lake I have only distributed about 5 of the 75 signs that I have. As such I will be retaining these signs only until Thanksgiving and returning the unclaimed signs to the Township Office in Whitney.

# **Household Waste Collection**

Reminder - the waste management bins will no longer be available at Aylen Lake. Please be respectful and refrain from dumping waste at the previous location.

Sunday - from May 1st to October 16th the waste collection truck will be located at the Aylen Lake Boat Launch from 12:00 pm to 4:00 pm. Please note that when Monday is a holiday, pickup will be on that holiday Monday not the Sunday of that week.

Wednesday - the waste collection truck will be located at the Aylen Lake Boat Launch from 2:00 pm to 3:00 pm.

Landfill Sites - The operation schedule from April 2 to November 2 - Wednesday 2:30 pm - 6:30 pm and again Saturday 8:00 am - 12:00 pm (noon). From May 1 - October 9 the landfill sites will also be open on Sundays from 12:00 pm - 4:00 pm

The landfill sites are now recycling electronics, tires (tires on rims are not accepted), steel and aluminum (ie beverage cans, pet food cans, foil, plates, siding). It should be noted that cans made of tin are not accepted. Aluminum must be clean and sorted. Please see the Landfill Site Attendant prior to disposing material to ensure proper location for disposal.

# South Algonquin Strategic Planning

The Township of South Algonquin is currently in the process of creating the Future Directions Strategy which is to be finalized early in the fall of 2016. Input into this Plan includes the Future Directions Survey 2016, Focus groups with Youth, Seniors, Tourism Operators and Council as well as two public meetings.

The first of the two public meetings was held on May 18, 2016 in both Madawaska and Whitney. I was able to attend the Madawaska meeting where we focused on defining the assets of South Algonquin as well as the establishment of a Mission and Vision Statement which will be used to guide the work to be done. The agenda for the meeting in Whitney was the same. The second meeting was held on June 6, 2016 where we worked on prioritizing goals and preparing some action plans

Synopsis of May 18<sup>th</sup> meeting – the meeting was a workshop type meeting and was facilitated by an independent resource. There were 5 participants from within South Algonquin, 3 of whom were residents on Aylen Lake. Concerns with respect to the time of the meeting were raised in that it was held during "normal" work hours as well as on a weekday. In order to increase the possibility of Aylen Lake seasonal residents being able to provide input it was requested that hardcopies of the survey be distributed on Monday May 23<sup>rd</sup> at the garbage pickup at the Landing.

Assets within Township – this is not an exhaustive list that came up at the meeting:

- Lakes and forests
- Sawmills
- Good people
- Good location access from 3 directions, proximity to Algonquin Park
- Fishing/Hunting/Snowmobile trails/ATV trails/Archery
- Community Centre (2)/Outdoor Rinks/Public Beaches (3)/Libraries (2)
- Firehall (2)/Medical Centre with 1 doctor and 1 nurse practitioner/Foot Clinic/Part of Physician Recruitment program at St Francis
- People oldest population in Nippissing/seasonal and cottagers
- Businesses -tourist resorts/campgrounds/artisans/trucking/cottage rental/sawmill

Vision – what do we want South Algonquin to look like in 10 years:

- Active, vibrant, attractive
- Inclusive of all ages and types of residents (permanent, seasonal, cottagers)
- Quain
- Upgraded tourist properties improved look and feel of community community pride
- Technology equivalent to "city" including remote areas
- Upgraded services for all residents

Synopsis of June 6<sup>th</sup> meeting – there were 6 participants – 5 of which were from Aylen Lake. Approximately 110 surveys were returned – with both seasonal and permanent residents responding. Once again this was a workshop type meeting where various goals under 8 categories were prioritized. There were a total of 52 goals collected up to this point in time. Possible actions for the top priority goals were discussed.

As we hear more information with respect to the development of the Strategic Plan we will let you know.

# Fire Pump Reminder

Please be advised that while there are no plans for a formal training session on the use of the fire pumps, you are all encouraged to get some hands-on training from the person who looks after the pump nearest you. Please contact them directly, and arrange for a demo at a mutually convenient time this summer. Trying to learn how to use the pumps when you are trying desperately to prevent a forest fire is probably much too late.

A fire map is included in this newsletter. In addition to the posted locations, Andrew Hassell (west shore of northern arm of the lake) has a pump on his dock whenever he is at the cottage, but locked

away when he is not. As well Bob Ogilvie has a pump located on is dock in Burnt Depot/Gaffney Bay from early May to October. We would like to remind those with pumps to please replace the gas and service the pumps as needed for the upcoming season.

Information for starting fire pumps:

Honda Pump (4 cycle-straight gas)

Wajax Pump (2-cycle-gas/oil mix)

START:

Install suction line, fill with water

Fuel lever ON and choke closed

Throttle 1/3 away from slow Ignition ON then pull starter cord

STOP:

Set throttle to slow Ignition OFF

**START:** 

Fill suction line with water

Connect fuel line then close choke


Push in overspeed switch

Set throttle to start; do not run without water in pump body

Pull starter cord and open choke

STOP:

Set throttle to slow to cool Ignition OFF

Fire permits are required for daytime burning. To request one contact Madawaska Fire Chief, Aurel Thom, at 613-637-5533 (Office) or 1-613-334-5018 (Cell). Fire permits for night 6:00 pm to 9:00 am is not required.

### Boat Safety – Avoid Dangerous Behaviours

Never try to spray swimmers, or cut in front of or try to jump the wake of other vessels. Some of the worst boating incidents happen when operators misjudge speed or distance.

#### Operate at a Safe Speed

Remember that you may have to stop or turn suddenly to avoid a collision, so operate at a safe speed. A safe speed depends on:

- your ability to see ahead slow is the only safe speed in fog, mist, rain and darkness;
- current, wind, and water conditions;
- how quickly your boat can change direction;
- how many and what types of vessels are near you;
- and the presence of navigational hazards such as rocks and tree stumps.

Be very careful when boating where visibility is poor, such as entering or exiting a fog bank.

A boat's wake can damage other vessels, docks and the shoreline. It can also be a risk for swimmers, divers and people on small boats that might capsize. Be aware of how your boat's wake might affect others when choosing your speed. You will be responsible for any damages or harm you cause.

#### Never Cruise with Booze

Mixing alcohol and boating is far more dangerous than you may think. Under normal conditions, sun, wind, the motion of the boat and even just being tired can dull your senses. Alcohol makes things even worse, slowing your hand-eye coordination and clouding your judgment.

Never cruise with booze! You might harm yourself or others. You are responsible for the safety of your guests and for not putting other waterway users in danger. Always be prepared and alert. Wait until you are safely on shore before having a drink.

Remember that impaired driving (whether on land or water) is an infraction of the Criminal Code of Canada. The consequences, even for a first offence, can last a lifetime.

#### Ontario Liquor Licence Act:

- No person shall operate or have care or control of a boat that is underway while there is contained in the boat any liquor, except under the authority of a licence or permit.
- Exception-Subsection (3) does not apply if the liquor in the boat, (a) is in a container that is unopened and the seal unbroken, (b) is stored in a closed compartment.
- A police officer who has reasonable grounds to believe that liquor is being unlawfully kept in a vehicle or boat may at any time, without warrant, enter and search the vehicle or boat and search any person found in it.
- Definition-In this section, "boat" includes any ship or boat or any other description of vessel used or designed to be used in the navigation of water.

# How to challenge your property assessment

#### Article taken from FOCA

There are a number of changes to the 2016 Request for Reconsideration (RfR) and Appeal processes.

\* NEW \* For the 2016 tax year, your deadline to file a RfR will depend on the date you receive your property assessment notice. The previous deadline (March 31 of each year) NO LONGER APPLIES.

What should you do if you don't agree with your assessment?

Step 1 – Visit aboutmyproperty.ca

Step 2 – Contact MPAC at 1 866 296-6722

Step 3 – Ask MPAC to Review your Assessment through a Request for Reconsideration (RfR) – click here to see the 2016 RfR form (pdf; 4 pages)

Read more, about these steps, below.

What to do if you have questions about your property's assessed value:

- 1 Ask yourself if you could have sold your property for its assessed value on the latest valuation date (January 1, 2016)?
- 2 Use AboutMyProperty (a free service) to make sure that it contains the most up-to-date information about your property. Note that MPAC have made some changes and on April 4, 2016 are launching a new site that should make it easier to <u>see the information on file for your property</u> and to <u>compare your property with others</u> in your area. You will have to register with the Roll Number and new Access Key on your Property Assessment Notice for the 2017 to 2020 property taxation years. You will not be able to access the site until you receive this Property Assessment Notice in the mail.

#### Still concerned?

3 – Contact MPAC at 1 866 296-MPAC(6722) and ask to review the value of properties similar to yours (up to 24 of your choosing). You can do this by visiting AboutMyProperty, and entering the User ID and Password included on your Assessment Notice, or, you can send a written request to:

For areas of the province where mapping is not available, you can search at the municipal level through an address search. If you want to look up a property that is not in your neighbourhood, but still within your municipality, you can enter the address in the property search window to get a "Property Detail Snapshot".

4 – If you still do not believe your assessed value is accurate, you can ask MPAC to review your assessment free of charge through a Request for Reconsideration (RfR).

RfR forms are available at www.mpac.ca or call MPAC to get a copy. You may also file your RfR electronically through AboutMyProperty. You will be able to attach documents, pictures and reports to accompany your RfR.

Write a letter requesting a RfR. In your letter, please include the 19-digit roll number on your Property Assessment Notice; your full name, address and phone number; and all the reasons why you feel your assessment is incorrect. The mailing address is:

Timeline for the 2016 RfR

Residential Property Assessment Notices will be mailed out across Ontario between April and August 2016.

You have approximately 4 months to request a RfR (<u>Please note your deadline varies depending on the date you received your 2016 assessment notice</u>). MPAC reviews such requests within 90 days, however, properties with unique or complex circumstances (like rural or waterfront properties) could take longer. Once the RfR is completed, MPAC will notify you of the results of the review in writing. If an adjustment needs to be made, the municipality will also be informed of the change so that your property taxes can be adjusted accordingly.

5 – You may also choose to file an Appeal with the Assessment Review Board (ARB), an independent tribunal of the Ontario Ministry of the Attorney General.

You have 90 days after MPAC has notified you of its decision on your RfR to file an Appeal with the ARB. The ARB has its own Appeal process. For more information, please contact the ARB at 1 800 263-3237or 416 314-6900or visit their website at www.arb.gov.on.ca. To enquire about your eligibility in the farm or managed forest classes or conservation land exemption, contact MPAC for more information.
